Powers: The President of BB Tecnologia e Serviços S.A. (BBTS), in the use of his attributions conferred by the norm of competences and powers (NI006, v.91, sub-item 7.1.1), resolves to designate the employees mentioned above as the Competent Bidding Authority, with a mandate until **06/10/2026**, and it should be noted that the acts carried out by said competent authority will comply with articles 69 and 70 of the BBTS Bidding and Contracts Regulations (RLC) prepared under the terms of Law 13.303/16.


Official Daiana Jacinto Rezende is hereby appointed as the incumbent Competent Bidding Authority, who may carry out acts relating to bidding processes, including acts appointing the members of the Bidding Committee, Special Committee, person in charge of the Bid and support team. Her alternates, in the event of the absence of the incumbent, will be employees Yasmim Silva dos Santos, Christine Dias Moreira and Tiago Martins Guedes.

For each bidding process, a Bidding Committee will be appointed made up of at least 3 (three) technically qualified members and BBTS employees, in accordance with current legislation and regulations.

It is also stipulated that a Special Bidding Committee may be formed made up of members with notorious knowledge of the matter under examination, specially appointed by the Competent Authority by means of the Special Bidding Committee Appointment Act (FQ415-006), all of whom are qualified employees belonging to the Company's permanent staff. The legal duties of the Competent Bidding Authority, the Bidding Committee, the Special Committee, the Bidding Manager and the Support Team are set out in the BBTS Bidding and Contracts Regulations (RLC) and NI415 - Supplier Contracting Process.
